\_\_\_\_\_ Option #3 We paid through FACTS last year, and we will **Re-Enroll** in the FACTS Automatic Funds Withdrawal Program for the 2018-2019 school year.

\_\_\_\_\_ Option #3A We are a **NEW** school family (or a current school family who did not pay thru FACTS last year) and we will **Enroll** in FACTS Mgt. Co. for the 2018-2019 school year.

Monthly payments are made through Electronic Funds Transfer or Credit Card on the 1<sup>st</sup>, 8<sup>th</sup>, 15<sup>th</sup> or 22<sup>nd</sup> of each month starting in August. A one-time set up fee of \$43.00 is charged, unless you have an active K-8 monthly FACTS account. FACTS accepts Master Card, Visa, Discover or American Express. **An add'l \$2.75 per \$100 is charged each time a payment is made using a Credit Card.** (Example: a fee of \$5.50 would be added to a credit card payment of \$200.)
